## **Inspection judgements**

### Overall experiences and progress of children and young people: good

There is a supportive and homely environment at the home. The child has personalised his bedroom, and the home is decorated and furnished in a manner akin to a family home. This contributes positively to the child settling and feeling comfortable.

An education plan is in place. The child attends education, and their educational needs are well understood by the staff.

The social worker and independent reviewing officer for the child confirm that the child is settled and making progress and that the child being enrolled at school is 'amazing'. They say that the child has good relationships with staff and is kept active.

The child is in good health. They are registered with primary health services and attend their appointments. Staff support the child to take responsibility for their health, which is important in preparation for adult life.

The child says that sometimes staff are overly attentive but enjoys activities with staff, such as going to the gym and visiting the farm to see the horses. He has a varied diet and chooses what he will have to eat each week. The child can make choices about their food and activities.

The child maintains regular contact with their family members, who are welcomed into the home. Staff support family time, which is important to the child's sense of self and identity.

### How well children and young people are helped and protected: good

There have been no incidents of the child going missing from the home or of behaviours requiring physical intervention. This is because the child and staff have positive relationships and resolve any issues through discussion.

Staff have a strong commitment to safeguarding the child through practical measures and risk assessments. Staff are actively involved in monitoring their activities. They are working hard to help keep the child safe. The child has a network of online friendships, which staff are aware about. Online safety is a continual challenge for the child.

There was an incident of the child being sent extreme material on his phone. The staff and manager took appropriate action by referring to the relevant services and liaising with education and the local authority. This was a significant event that was



not notified to Ofsted at the time. This means that the regulator was unaware of some of the issues that the child was facing.

The locality risk assessment provides a general overview of risks but lacks specific details on emerging threats and collaboration with local police, which could enhance its effectiveness.

Health and safety measures, including regular fire drills and checks, are in place to ensure a secure environment for the child.

### The effectiveness of leaders and managers: good

The home is managed by an experienced manager who is child-focused and committed to her role. The manager knows the child very well and advocates for them. This ensures that the child receives care that is appropriate to their needs.

Staff are offered regular formal and informal support. Supervision records are detailed, and staff are offered the opportunity to reflect on their work with the child. Staff say that they feel supported by the manager and leadership team and that they are committed to their role.

The staff group is stable, and the rota system ensures that there are enough staff providing care and promoting stability for the child. This helps to ensure the child has a safe, structured and predictable routine.

The manager has not put in place a staff workforce development plan, to enable planning for staff structure and to support staff.
